Welcome

- Zachary Jordan began the meeting by welcoming everyone to the meeting in the retail space, and stating that doing the meeting via video format was easier due to the holidays quickly approaching, and that it would accommodate better with everyone's schedules.
- Zachary Jordan also stated that the agenda and strategic plan is available on the AB-Tech website, for those who would like to have a hard copy of the meeting.

Program Current Success and Status

- The capacity for enrollment has been changed from 16 to 20 students who can enroll into the program, due to the amount of computer access available for students.
- There were 17 students that were enrolled his fall, but some had dropped the program before it had started, and some dropped in the middle of the semester due to financial issues or failure to pass classes.
- Second year students all came back for the fall semester with the addition 3 more students, one of which has completed the program for the diploma.
- Zachary Jordan express the excitement of adding new technology to the program, after discussing with a locally owned pharmacy about what programs they use in their pharmacies called Pioneer Rx.
- The program is user friendly and is utilized more, and will help students learn with the most up to date programs and technology used in retail settings, such as a thermal printer, scanner, label printer, and barcode scanner, which have all been installed this past semester.

- Zachary Jordan also states that students are still utilizing drug quizzes on the online format, it helps with the faculty work load when it comes to grading, though every once in a while there are some mistakes found with the questions but it is just a matter of going in and fixing that question.
- Zachary Jordan mentions that there is one new adjunct added to the program and states that Perry Fong has left in spring of this past year, and that the program is introducing Carolyn Alburn a pharmacist whom as work at Wal-greens, CVS, and Kerr Drug, and that she will be helping according with her expertise in retail.
- This Carolyn's first semester teaching, but that she is doing relatively well, and most students seem to like her.
