

A-B Tech External Event Attendee Code of Conduct and Acknowledgement

While on site at the campuses of A-B Tech, visitors are expected to behave in a manner that is lawful and respectful of others. During the COVID-19 Pandemic, this Code of Conduct has been implemented to ensure that a consistent approach to visitor behavior is achieved in order to provide a respectful and safe environment for all college staff, faculty, students and visitors.

Facial Covering Expectations at A-B Tech as of 7/22/2020

In the interest of the health and safety of you, your loved ones, and all others, we are implementing the below facial covering requirements:

- Facial coverings must be worn inside buildings at all times, including, common areas, hallways, bathrooms, classrooms, parking facilities, etc. even if 6 ft. physical distancing is possible.
 - The only exception will be when an employee is alone in their office or instructing students remotely while alone in a classroom.
- Must be worn while entering/exiting buildings and rooms.
- Must be worn for the duration of an event, even if seating allows for 6 ft. physical distancing.
- Must be worn outside if within 6 feet of anyone else.
- Should NOT be worn by anyone under the age of two.
- Must be an acceptable covering and worn properly.
 - Must cover your nose and mouth.
 - Cloth coverings or disposable paper masks that filter exhaled air are acceptable.
 - Mesh-like or woven fabrics with noticeable gaps and any covering with a valve that does not filter exhaled air are NOT acceptable.
- Failure to comply could result in being asked to leave campus.

Monitoring Expectations

- **Temperature checks:** Check before coming to campus and stay home if you have a low-grade fever.
- **Screenings:** If you have been in close contact with anyone with COVID-19 or have [COVID-19 symptoms](#), do not come to campus. - **Self-isolation:** If you suspect or have COVID-19 symptoms, do not come to campus.
