Comments:

- 1. South Carolina: Out-of-state LE applicant must submit proof of NC BLET completion, copy of BLET curriculum/syllabus, Training Review Request, and other documents to SC POST (Police Officer Standards and Training) Commission. Previous LE training and experience is evaluated on a case-by-case basis and the applicant is then advised of training requirements for SC certification as LEO. There is no full exemption or waiver for out-of-state LE applicants.
- 2. Virginia: Previous LE training and experience is evaluated on a case-by-case basis and the applicant is then advised of training requirements for law enforcement officer certification. There are no complete training exemption or waiver for out-of-state transfers into Virginia. Requests for partial training

waiver is made by the hiring law enforcement agency, not the applicant, and agencies have the option of requiring out-of-state transfers to complete the entire basic academy, regardless of the applicant's prior training/experience.

- 3. Georgia: Georgia allows certain out-of-state LE applicants to participate in the Equivalency of Training (EOT) process, and the results of this process determine how much GA-required training the out-of-state applicant must complete prior to being issued a basic GA law enforcement certification.
- 4. Tennessee: Out-of-state LE applicants must first be hired by a Tennessee law enforcement agency. The employing agency would request the TN POST commission to certify the new employee. Upon approval by TN POST, the applicant must satisfactorily complete a three-week transition school prior to being issued a full LEO certification.
