

### **Preferred First Name Request**

A-B Tech will allow a student to request a preferred **first name** for display in Moodle, student email accounts, and on the A-B Tech student ID card. A preferred first name can be requested at any time; however, preferred first name changes cannot be processed during a term. Preferred first names will only be processed between terms.

This form is solely for preferred first name requests. If you have a legal name change, please refer to the instructions for how to submit a Change of Vital Data form on our website: <u>https://abtech.edu/</u>future-students/student-records/name-and-address-change

The College reserves the right to deny a preferred name if it exceeds any technical software limitation or is deemed inappropriate. A student may request a preferred first name up to two times. The legal name will only be changed in accordance with College policy.

Students are reminded that the legal name is considered directory information under the Federal Education Rights and Privacy Act (FERPA) and can be provided upon request to any entity unless a request for privacy has been submitted to the College. The legal name is available to College employees for the purpose of conducting College business. This form can be submitted electronically from your student email account to registrar@abtech.edu .

## **Preferred First Name – Frequently Asked Questions**

#### • Question: Where will my preferred name be displayed?

Answer: Your preferred name will be the name displayed to you and other classmates in Moodle. The display name in your student email account will also be your preferred name. Your student email account in Outlook/Microsoft 365 will have what's called an "alias" email address that will allow you to send and receive email using your preferred name in addition to your legal name. You can tell others to contact you at the email address that has your preferred name. Class lists for instructors will have your legal name *and* your preferred name (with your preferred name in parentheses). You can also use your preferred name to sign in at the electronic kiosk in the Bailey Building lobby, and you can have your student ID card printed with your preferred name. If you complete a program at A-B Tech, your preferred name can be printed in the commencement program list of graduates and on your diploma.

#### • Question: Where will my legal name still be displayed?

Answer: Your legal name will be used for your login username for Self-Service, Moodle, and student email account, which can't be seen by students or faculty. It will also be displayed at the top of Self-Service when you log in. It will always appear on your official A-B Tech transcript, 1098-T student tax forms, W-2 tax forms (if you are employed by the College), the basic application to A-B Tech (through the CFNC system), the Residency Determination Service and any documents related to residency for tuition purposes, and FAFSAs (financial aid documents). There are also rare cases where system maintenance in Moodle can cause the display name to revert to a student's legal name. If this happens, you can contact our IT HelpDesk at (828) 398-7550 or helpdesk@abtech.edu and they can get it fixed right away.

#### • Question: Who can I turn to if I have questions?
